Prom Guest Permission Form

In order to attend the LCA Prom, all guests must agree to comply with the following guidelines and submit the completed Guest Permission Form to Coach Galloway by Friday, March 29th. The LCA Prom will be Saturday, April 13th at 8:00 p.m. Once approved, the guests name will be added to the prom dance roster.

1. All school rules are in effect.
2. Only one guest per student of the opposite gender.
3. The dance will begin at 8:00 p.m. and finish by 11:00 p.m. All dance attendees and guests must arrive before 9:30 pm, at which time the doors will close.
4. All guests must present some type of picture identification (school ID or driver's license) in order to enter the dance.
5. Guests may not be a junior high student and may not be over the age of 20.
6. Any guests or LCA students that choose to leave the dance prior to 11:00 p.m. will not be allowed to return.
7. Any guests in possession of alcohol or drugs or found under the influence of such substances will be denied entrance to the dance, referred to the proper authorities, and reported to the guest's school. LCA reserves the right to use breathalyzers.
8. Any guests who do not comply with the directives of the administration or chaperones will be removed from the dance.
9. All female guests must adhere to the following LCA Prom dress guidelines:
 - *Dresses must not have a plunging or revealing neckline (e.g. too much cleavage)*
 - *The hem of the dress (including any sheer material and slits) must not be higher than three inches above the knee*
 - *Dresses must not have cutouts below the necklines or sides (avoid the "V" cut)*
 - *The backside of the dress must not be lower than the waistline*
 - *Dresses must not have bare midribs (including sheer material).*
